- *understand the slip allocated accommodates the watercraft prior to my\our docking at Calabogie Lodge Resort. All watercraft must be docked at an allocated slip.*
- *will ensure that the watercraft is secured to the slip using my own rope and bumpers.*
- *will remove the watercraft from the lake should there be the potential for wind or a storm.*
- *understand that the Calabogie Lake levels will fluctuate, This is not controlled by Calabogie Lodge Resort.*
- *understand there could be potential risks and hazards on Calabogie Lake and I do not hold Calabogie Lodge Resort liable for any incidents\accidents that occur at the slip or on the Lake.*
- *understand, as a Resort Guest, Calabogie Lodge Resort is not responsible for theft or damage of watercraft, trailers or any personal items\equipment.*
- *understand, Calabogie Lodge Resort will not assume any liability with regards to your decision to use Calabogie Lake for your enjoyment.*

GENERAL RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT:

DEFINITION:

In this agreement, the term "Activities" shall include all activities in any way related to water sports, kayaking, canoeing, tennis court, use of trails, deck and patio, kayak, hot tub and pool use, swimming, use of slide dock, slips snowshoeing, and including all recreational activities offered (hereinafter referred to as "The Activities")

ACKNOWLEDGEMENT

I\We, acknowledge that I\We, have been advised to wear life jacket and have in the watercraft an orange safety bucket, while using the Watercraft. When participating in all Activities. Instruction in proper use of the life jacket and **orange safety bucket is available from the staff at sign out.** I am aware that the physical exertion required by The Activities and the forces exerted on the body can activate or aggravate pre-existing physical injuries, conditions, symptoms, or congenital defects. I have been advised to seek medical advice if I know or suspect that my physical condition may be incompatible with The Activities. I acknowledge that I am not nor will I be under the influence of drugs or alcohol while participating in The Activities.

ASSUMPTION OF RISKS:

I am aware that The Activities involve many risks, dangers and hazards including, but not limited to: The overturning or upsetting of watersports equipment, falling from the watercraft or slip\ dock slide, impact or collision with rocks, trees, logs, deadfall, other vessels, and other water equipment; high winds and inclement weather; equipment failure; variation in the water conditions, surfaces and currents; and negligence of other guests. Falling, tripping or sliding on trails, dock slide, beach, stairs, all decks, patios or docks. I\we are also aware that hiking, involve many risks, dangers and hazards, including but not limited to: steep slopes in their natural state that may contain many obstacles and hazards; terrain that may not have been traveled on or climbed before and is not regularly patrolled or inspected.

I FREELY ACCEPT AND FULLY ASSUME ALL RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE ACTIVITIES AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE AND LOSS RESULTING THEREFROM. RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT. NEGLIGENCE ON THE PART OF 'THE RESORT', INCLUDING THE FAILURE BY THE RESORT AND THEIR STAFF TO SAFEGUARD OR PROTECT US\WE, FROM THE RISKS, DANGERS AND HAZARDS OF THE ACTIVITIES.

TO WAIVE ANY AND ALL CLAIMS that I have or may have against Calabogie Land Co. (Calabogie Lodge Resort), THE RESORT AND THE PROVINCE, AND THEIR DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, GUIDES, INSTRUCTORS, INDEPENDENT CONTRACTORS, SUBCONTRACTORS AND REPRESENTATIVES (ALL OF WHOM ARE HERINAFTER REFERRED TO AS THE "RELEASEES") AND TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer as a result of my participation in The Activities, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT, ON THE PART OF THE RELEASEES, AND FURTHER INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF THE ACTIVITIES REFERRED TO ABOVE.
